

STREET NAME CHANGE

1. **Application fee:** \$1,672
\$1,600 + \$72 (4.5% I.T. Recovery Fee)
Street Signage Fees: (determined on a case by case basis by SAC DOT)
2. Street Name Change Application Form
3. Exhibits depicting the entire stretch of road impacted by the street name change and depicting APN's of all properties impacted by this change.
4. Petition containing all affected property owner signatures for all affected properties.
 - Petition must have at least three recommended street names
 - Street names must conform to Sacramento County Street Name Standards
 - Petition must state the reason for requesting a street name change
 - All affected property owners must consent to the street name change and agree on a specific street name
 - The applicant may also be required to obtain written concurrence from any pertinent service providers such as Fire Department, Sheriff, and U.S. Post Office
5. Technical Resources will process and schedule for Board agenda
6. After street name approval, Technical Resources will notify all affected property owners and service providers of the approved street name change.
7. Technical Resources will submit street sign name change request to Transportation Maintenance (Lupe Rodriguez: 875-5991).
