## Brief description of the type of fee in the program fund:

The Vineyard Springs Comprehensive Plan Southgate Recreation and Park District Park Improvement Development Impact Fee was established to finance basic park improvements, a portion of a community center, tot lots and recreational fields and miscellaneous structures, and open space and trail facilities in the Vineyard Financing Plan area that is within the Vineyard Springs Comprehensive Plan area. Facilities are detailed in the Vineyard Public Facilities Financing Plan Development Impact Fee Program Nexus Study approved by the Sacramento County Board of Supervisors on February 7, 2006.
