

**RESOLUTION NO. 2018-0077**

**RESOLUTION ADOPTING REVISED IMPROVEMENT STANDARDS,  
EFFECTIVE APRIL 1, 2018**

**WHEREAS**, the Board of Supervisors of the County of Sacramento, State of California deems it necessary and prudent in the interest of the public to revise the existing Improvement Standards governing the design and construction of roads, streets, sanitary sewers, storm drainage, concrete structures, water supply, street lighting, land grading, erosion and sediment control, and other pertinent facilities within the County of Sacramento to provide for proper development.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that the attached Improvement Standards are hereby adopted on this date as the County of Sacramento Improvement Standards;

**BE IT FURTHER RESOLVED AND ORDERED** that except for the changes contained in the attached Improvement Standards, the remaining provisions of the Improvement Standards previously adopted by the Board pursuant to Resolutions 2006-0994 and 2009-0718 (i.e., Sections 4, 5, and 9) shall remain in full force and effect; and

**BE IT FURTHER RESOLVED AND ORDERED** that the attached Improvement Standards shall be effective and apply to all Improvements Plans received by the County on and after April 1, 2018; and

**BE IT FURTHER RESOLVED AND ORDERED** that the Board hereby delegates to the County Engineer authority to approve, issue and publish minor administrative clarifications and regulatory changes required by various state and federal or other regulatory agencies.

**BE IT FURTHER RESOLVED AND ORDERED** that the attached Improvement Standards and Standard Drawings adopted herein, together with the Standards Construction Specifications and the references included therein to the Standards Specifications of the State of California, shall govern the design and construction of improvements in Sacramento County.

On a motion by Supervisor Kennedy, seconded by Supervisor Peters, the foregoing Resolution was passed and adopted by the BOARD OF SUPERVISORS of the County of Sacramento, State of California, this 6<sup>th</sup> day of February, 2018, by the following vote, to-wit:
