BACKGROUND:

In 2004, the Sacramento County Board of Supervisors (Board) took the following action, under the terms and provisions of the Mello-Roos Community Facilities Act of 1982, being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of California (Act), to establish the County of Sacramento Community Facilities District No. 2004-2 (Landscape Maintenance) (Countywide LM CFD) for the purpose of financing landscape maintenance services for public landscape corridors within the district and associated administrative expenses:

Adopted Resolution No. 2004-0271 establishing the Countywide LM CFD and providing for the levy of a special tax to finance landscaping maintenance services (3/16/2004).

The services authorized for funding from the Countywide LM CFD special taxes are listed in Exhibit A to Resolution No. 2004-0271. This report contains the reporting elements required by Section 53343.1 of the Act. A map of the district is shown on the attached Figure A.

A. SPECIAL TAXES COLLECTED:

Special taxes levied for Fiscal Year 2021-22 amounted to \$247,275.

Special taxes that were delinquent for Fiscal Year 2021-22 amounted to \$1,372 (as of July 1, 2022).

Special taxes collected for Fiscal Year 2021-22 amounted to \$245,903 (as of July 1, 2022).

Previous year delinquent special taxes collected in Fiscal Year 2021-22 amounted to \$1,280 (as of July 1, 2022).

B. OTHER REVENUE RECEIVED:

Interest earned for Fiscal Year 2021-22 amounted to \$2,753.

C. TOTAL EXPENDITURES:

The total amount expended in Fiscal Year 2021-22 was \$321,849.

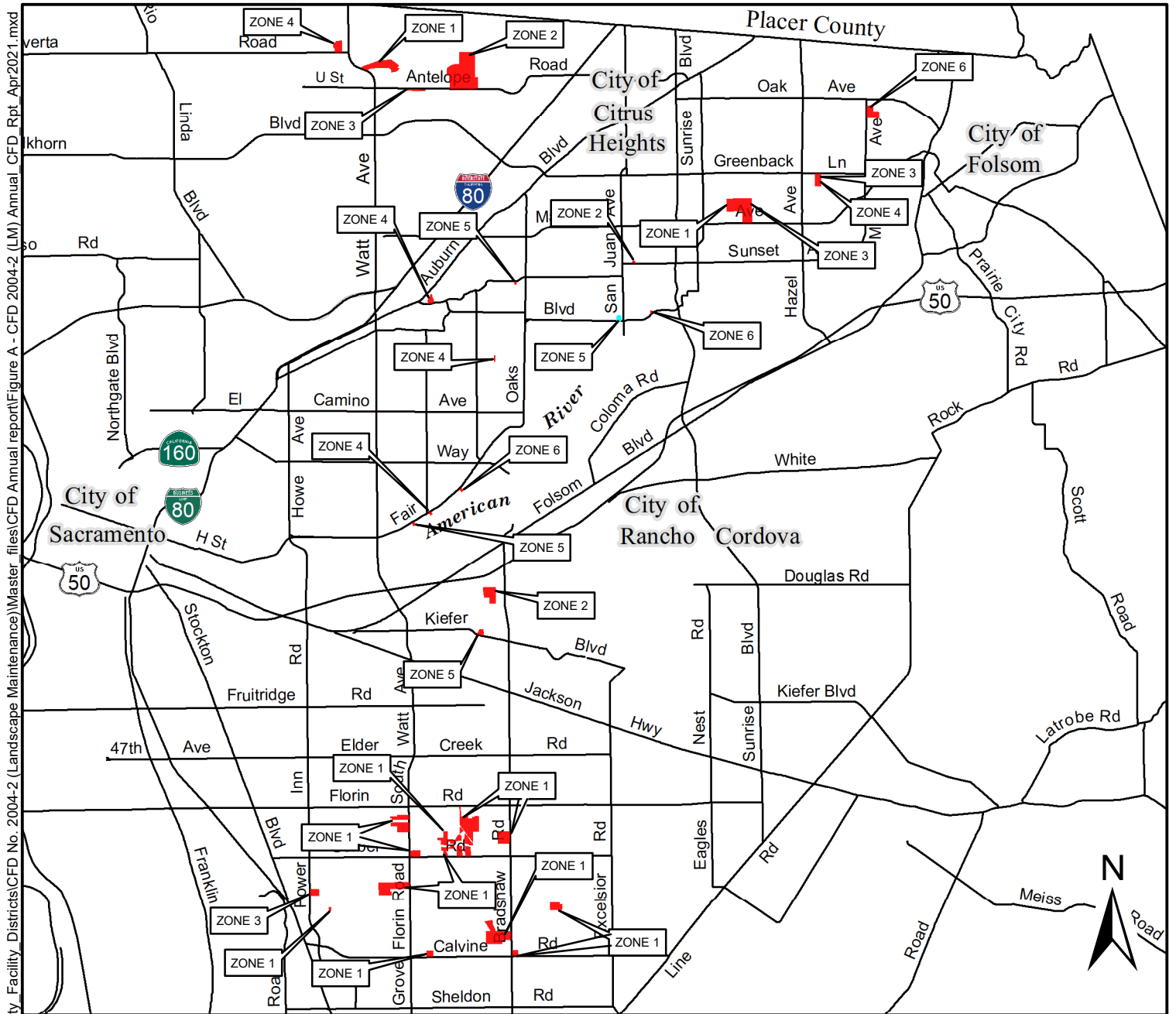

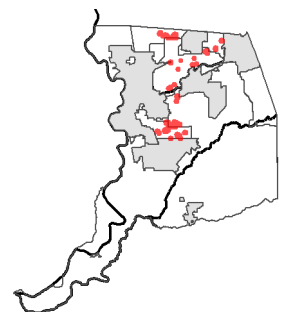
